Background

This report updates Report 14-42, dated September 30, 2014 with respect to Open Child Agency grants recommended for follow-up. Information available in ARC.Net and latest available Basic Agency Monitoring Reports (BAMR) was used to identify current grant status and grants recommended for continued follow-up and necessary action.

The annual BAMR provides detailed information about the status of construction related grants administered by other Federal agencies for the Appalachian Regional Commission. BAMR information permits more timely follow-up and emphasis was placed on identification of projects without reported activity for a lengthy period.

Recent BAMR reports provided information indicating progress in 32 of 73 grants identified in Report 14-42 including completion in several cases, construction in progress and updated intentions to proceed in other cases and one de-obligation of \$300,000. Continuing follow-up is recommended for grants noted in table A. Table A includes 26 grants approved prior to September 21, 2011 and 15 grants approved prior to September 26, 2012. The 41 grants identified included grants included in prior reports for which projects were not to be implemented, grants for which updated information was not available and projects that required significant action, such as acceptable bids, State or other agency actions in order to be implemented. In some cases the constraints to progress has lasted several years. Table A includes comments on the grant status and the obstacles or needs to permit project implementation. Of particular significance is five grants where information has been provided to ARC that the projects will not be implemented.

For three grants an updated BAMR was not available and for 34 grants there was no reported construction.

Actions were initiated for 15 of 23 grants identified in table C of Report 14-42 with respect to small balances or significant time since prior payments. This included four de-obligations totaling \$87,368. The open eight grants are included in table B.

Fourteen open HUD administered grants with needed de-obligations of \$423,870 were included in Report 15-16 and are not included in table A.

Follow-up should be initiated on the grants noted in tables A & B, including closings and deobligations and use of funds for other needed projects. Controls should be established to assure actions are initiated timely based on information from Child Agencies.
